### Rights granted to the Company

### Responsibilities, Permissions and Confidentiality

1. To the best of my knowledge and belief, my Contribution will not infringe any copyright or any other individual's rights; is truthful; not defamatory or in contempt of court.
2. I give all necessary consents required by law to enable the Company to use my Contribution as it desires.
3. I understand that the Company will not be liable for any loss or damage to me or my property unless caused directly by the Company's negligence.
4. I shall not either personally or by other means make any statement or disclose any confidential information or methods of production to any third party relating to the recording of my Contribution or the Programme without the prior written consent from the Company.

### How the Production Company uses your Personal Data

1.
